





# Monitoring Air Quality in the Stockton AB 617 Community

#### MAIN POLLUTANTS OF CONCERN

PM2.5: small particulate matter


- Emitted from fuel burning (wood smoke, diesel trucks, industrial sources, etc.)
- Created in air through other pollutants (mostly NOx, which comes mainly from mobile sources)

**DPM**: diesel particulate matter

Mostly from diesel trucks

NOx: oxides of nitrogen

- Mostly emitted from mobile sources (trains, trucks, cars)
- Creates PM2.5 and smog (ozone)





## **Community Air Monitoring Plan (CAMP)**

### **GOALS**

- Monitor real-time air pollution in Stockton community
- **Identify** sources of community air pollution to continue to inform the CERP implementation process
- •Inform community about hyperlocal air quality
- Track air quality trends over time

### APPROACH


Worked with CSC to identify sources of concern, priorities for monitoring locations, and sites to deploy real-time, high-quality air monitoring units

### STATUS

- •4 of 8 sites deployed, displaying real-time data on community website
- Working with landowners and CSC members on the remaining sites

## Community Air Monitoring Plan (CAMP)





### Community Emissions Reductions Program (CERP)

GOALS

Reduce air pollution and exposure to air pollution in the Stockton AB 617 boundary through partnerships, incentives, education, outreach, enforcement, and regulations

**APPROACH** 

Worked with CSC to inform development of several measures, including \$32 million in incentives, for inclusion in the Community Emissions Reduction Program (CERP)

#### Stockton Community Steering Committee Charter Updated August 4, 2021

#### 1. Committee Objectives

The Stockton AB 617 Community Steering Committee is a special committee that will be responsible for advising the San Joaquin Valley Air District's development of the Community Air Monitoring Plan (Monitoring Plan) and Community Emission Reduction Program (CERP) under AB 617<sup>1</sup>.

Committee objectives include identifying areas of concern regarding air pollution sources within and outside of the Community that impact the Community and sensitive receptor sites, and reviewing existing available information on air quality to provide strategic input towards Monitoring Plan and CERP development. Committee objectives also include disseminating and soliciting information to and from community stakeholders that each committee member represents. Upon adoption of the CERP, the steering committee may continue to meet as needed to support and provide guidance on implementation, and develop progress reports.

#### 2. Roles and Responsibilities

#### Community Steering Committee Members

The Steering Committee will consist of community stakeholders, the majority of which must be community residents. See Attachment A, AB 617 Community Steering Committee Selection Criteria, for more details on Steering Committee membership requirements.

To inform their role of advising the District in its development and implementation of the CERP, the Committee members will be responsible for discussing a variety of topics including:

- community issues and contributing sources to develop a shared understanding of the community's air pollution challenge;
- who has responsibility and authority to address those issues;
- proposed strategies for the community emissions reduction programs;
- · mechanisms for engaging with other agencies;
- approaches for additional community outreach;
- other topics of interest to the committee.

The committee will discuss the major elements of the CERP as they are developed including:

- community engagement;
- · the community profile and technical assessment;
- targets and strategies; the enforcement plan; and metrics to track progress.

Government official committee members serve as ex-officio full participants in the committee, except that they serve in an advisory role, not a voting role, in final consensus building and
