I am happy to report that I believe that SUSD has completed the Air Pollution District/CARB \$4,000,000 - 10 Bus Application with data submitted yesterday. Additionally SUSD will be submitting signed papers tomorrow to proceed with a 20 Bus EPA Grant and a 10 Bus HVIP Grant. In all, SUSD is now on target to purchase 46 Electric Buses this fall. We are also close to having funding to retrofit air conditioning to nine (9) existing electric buses. All new buses will be airconditioned. SUSD is in position also to more than double our bus charging infrastructure from 21 to about 50 depot chargers. I must leave at 6:45 pm. Thank you all!
