Under the Global Warming Solutions Act, we need costs per MT CO2E emission reduced per year. That type of cost for CO2E should be developed for other chemicals by emissions and exposure per MT. Then emissions and exposure should be measured, and compare to computed, projected numbers.

10 years is good.

The plan should prefer locations that would have a likely beneficial effect on childhood asthma. Thus near schools and in conjunction with the Office of Environmental Health Hazard Assessment (OEHHA) programs. It should be part of rational, cogent health studies. Must be appropriate air monitoring, e.g., street facing outside barrier, inside barrier, inside classrooms.

Report periodically on results: designed, projected, actual, by emission, exposure and health outcomes. Must have economic analysis, e.g., cost per MT reduction in emission, exposure, and cost per reduction in health metrics, e.g., ER visits, other measures of morbidity, mortality relating to asthma etc.
