# Passenger Vehicle Repair & Replace Measures Updates

- Project Plans for Passenger Vehicle Repair and Replace programs **approved** by CARB and District Governing Board
  - **Passenger Vehicle Repair Measure:** Funding for vehicle emissions related repairs for high polluting vehicles operating in the Stockton AB 617 community
    - **Funding allocation:** \$300,000
  - **Passenger Vehicle Replace Measure:** Funding for replacement of passenger vehicles with battery electric or plug-in hybrid vehicles
    - **Funding allocation:** \$800,000
- **Next steps:**
  - **October/November:** Work with CSC on program outreach and implementation
  - **Today:** Discuss opportunity to increase funding amount for **Vehicle Replacement Measure**

# Passenger Vehicle Replacement Measure: Opportunity to Increase Funding Amount

## Current Program

Vehicle Type		Plug-in Hybrid	Electric
300% Federal Poverty Level and below	NEW/USED: Plug-in hybrid electric or zero-emission vehicle purchase	\$11,500	\$12,000

## Proposed Program

Vehicle Type		Plug-in Hybrid	Electric
300% Federal Poverty Level and below	NEW: Plug-in hybrid electric or zero-emission vehicle purchase	\$18,000	\$20,000
	USED: Plug-in hybrid electric or zero-emission vehicle purchase	\$11,500	\$12,000

*\*Currently, no change to funding allocated in CERP, can be opportunities for reallocation if needed*

# Passenger Vehicle Replacement: Funding Opportunities and Implementation Considerations

- Today's discussion is about increasing the incentive amount available per vehicle in Passenger Vehicle Replacement program
  - Funding allocation remains the same: **\$800,000**
- If we see high participation in program, we can look to reallocate funds to support measure
  - Over \$2.4M remaining (from School Air Filtration Measure) for reallocation in other measures as necessary
- If supported by the CSC, District will submit updated project plan to CARB
  - Have opportunity to make update ahead of program opening later in October

# Analyzing Equity Among Electric Vehicle Rebate Programs

Key “ingredients” for ensuring EV rebate programs are equitable include:

- High rebate amounts for low-income qualified applicants that can be applied directly to the purchase or lease of a new or used EV
- Rebate programs include robust public education and accessibility initiatives that are specifically designed to increase the number of low- and moderate-income applicants

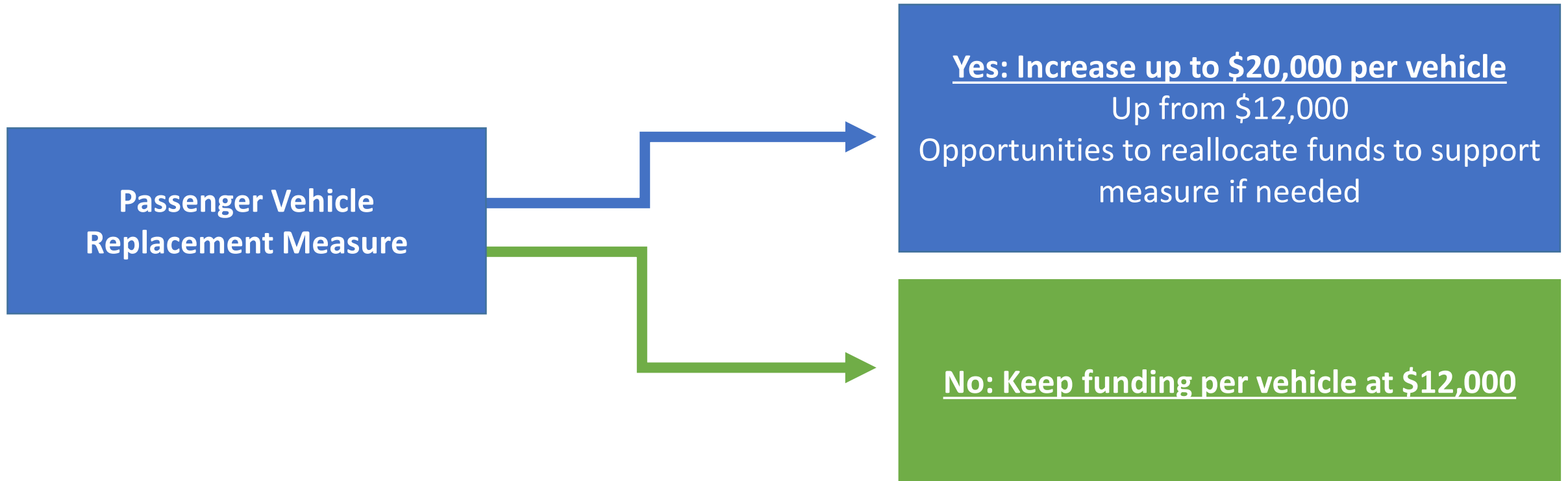
### Analyzing Equity in Statewide Electric Vehicle Rebate Programs
