18:25:22 From Nate Knodt : Central California Traction Co (CCT) Railroad is Stockton-based and the Official RR of the Port of Stockton. It is jointly owned by UP & BNSF and operates between the Port, Cherokee Road, and Lodi. It still has tracks in place to operate to South Sacramento via its own right-of-way via Morada and Sheldon between Stockton, Lodi, and Sacramento. CCT primarily switches freight

cars from the Port to UP and BNSF in Stockton. It also connects to UP in Lodi for food processing plants. CCT is an excellent operation to pioneer use of Electric Switching Locomotives and other freight loading HV EV Equipment. Another Stockton Short Line, the Stockton Terminal and Eastern RR should also be considered. ST & E primarily does switching to and from food processing plants in East Stockton to UP and BNSF. It still has tracks in place to Linden, but not used in 40 years.
