APPENDIX D**FACILITY RISK REDUCTION AUDITS UNDER AB 2588 (AIR TOXICS HOT SPOTS INFORMATION AND ASSESSMENT ACT)****Community-Based AB 2588 Reassessments**

The table below identifies the AB 2588 reassessment status of each facility within the community, as of May 17, 2022. The AB 2588 reassessment status for each facility is presented in the table below utilizing one of the following status definitions:

- *Agricultural*: A facility growing crops or raising fowl or animals.
- *Exempt - De minimis*: Low health risk levels according to Appendix D of the Emissions Inventory Criteria and Guidelines Reporting (EICGR). These facilities are exempt from further analysis under AB 2588 at this time due to being a low health risk.
- *Exempt - Low Priority*: The facility completed a plan and report, generated a prioritization score and expected to generate low health risk levels. The facility is exempt from further analysis under AB 2588 at this time.
- *High Priority*: District has notified the facility that a Health Risk Assessment (HRA) is required.
- *Industrywide*: Small businesses where emissions can be generally characterized such as Gasoline Dispensing, Auto Body Coating, etc.
- *Intermediate Priority*: Facility required to provide an operational and emissions status update summary on a quadrennial basis.
- *Intermediate Risk*: An HRA was required and resulted in a cancer risk score between 1 and 10 in a million and/or a non-cancer hazard index score between 0.1 and 1.
- *New Facility*: A facility that has recently been issued permits to operate by the District.

Arvin/Lamont

There are currently 79 District permitted facilities located within the selected community of Arvin/Lamont (see Table 1 below).
