## CERP Measure Category: Incentives

### Incentives Programs



District and CARB incentive funding to support expedited deployment of the cleanest technologies **beyond what is required by regulation** 

#### Examples:

- Funding schools to replace old school buses with electric technologies
- Funding to replace old, high-polluting trucks with cleanest technology



## CERP Measure Category: Land Use and Agency Partnerships

Land Use and Agency Partnerships



California Department of Pesticide Regulation



Strategies that focus on active engagement with agencies to promote clean air measures outside of District and CARB jurisdiction

### Example:

- Work with City of Arvin or Kern County on road paving projects or truck rerouting study
- Work with DPR regarding pesticides



## **CERP Measure Categories: Enforcement**

### Enforcement

Enforcement of air quality rules and regulations is responsibility of the District and CARB (mobile sources). Identify and include near-term enforcement strategies to improve compliance with existing rules

#### Examples:

- Enhanced enforcement of illegal burning in community
- Enhanced enforcement of CARB anti-idling regulations for heavy-duty trucks



## CERP Measure Category: Enhanced Outreach and Exposure Reduction

Enhanced Outreach and Exposure Reduction



Identify additional means to reduce localized air pollution exposure

#### Examples:

- Install vegetative barriers between a school and nearby freeway
- Increased community education and outreach through multi-lingual fliers and workshops
