TABLE #1 – Bike Lanes

Measure Goal: Funding to support construction of bike paths in the Stockton AB 617 community

TABLE #2 – Passenger Vehicle Repair and Replace

Measure Goal for Passenger Vehicle Repair: Funding for vehicle emissions related repairs for high polluting vehicles operating in the Stockton AB 617 community

• Measure Funding Available for Repair: \$300,000

Measure Goal for Passenger Vehicle Replace: Funding for replacement of personal vehicles with battery electric or plug-in hybrid vehicles

• Measure Funding Available for Replace: \$800,000

The District will discuss the launch of these two programs and propose funding reallocation to the passenger vehicle replacement measure to allow more residents participate in the program, based on existing demand in the community.

Project Name: Stockton Safe Routes to School Safety and Connectivity Improvements Project

Allocated AB 617 Funding: \$500,000

<u>Project Description:</u> Funding for installation of bike lanes near several elementary, middle and high schools to increase safety and active modes of transportation

<u>Opportunity with Bike Path CERP Measure:</u> Leveraging funds to support City of Stockton project, which aims to increase safety and active transportation through construction of bike lanes, missing sidewalk, curb ramps and safety features (installing high visibility crosswalks with flashing beacons) in disadvantaged communities

Summer 2024: Anticipated construction begins




TABLE #2 – Passenger Vehicle Repair and Replace

Opportunity for Funding Reallocation for Passenger Vehicle Replace Measure

Measure Progress:

- During October 2023 CSC meeting, CSC supported increasing the funding available for a new plug-in hybrid or electric option to up to \$20,000 per vehicle with potential to increase funding to measure if needed
- Project Plan approved by CARB, finalizing contract with Valley Clean Air Now (ValleyCAN) and anticipate opening program in coming weeks
- In preparing for opening of program, we already see a demand in Stockton community through Valleywide program

Allocated AB 617 Funding: \$800,000



With existing \$800K in funding, between ~40-70 residents can participate in program depending on the type of vehicle they choose. During one ValleyCAN outreach event, they typically will help complete ~50 applications and we are already seeing high interest in the Stockton area to participate in the Passenger Vehicle Replace program.

Opportunity for Funding Reallocation for Passenger Vehicle Replace Measure:

Currently, over \$2M remaining for reallocation in other measures as necessary

AIR DISTRICT MOBILE AIR MONITORING VAN

The District uses the air quality monitoring van to get local, accurate data on our Central Valley communities. It has safe and high-tech instruments that measure different types of pollution, including PM2.5, ozone, NO₂, BTEX, SO₂, black carbon, and H₂S. This van responds to community concerns, so you may see it driving through your community or parked in your neighborhood.

The van will be parked outside. Please feel free to visit District air monitoring staff, who will be available to answer questions and share information about the District's mobile monitoring efforts
