

# COMMUNITY AIR PROTECTION PROGRAM IMPLEMENTATION IN THE VALLEY

The communities of Shafter, South Central Fresno, Stockton and Arvin/Lamont have been prioritized by the San Joaquin Valley Air Pollution Control District (District) and subsequently selected by the California Air Resources Board (CARB) as communities in the San Joaquin Valley to receive clean air resources available under AB 617. AB 617 provides mechanisms and resources to implement community-specific air quality monitoring networks; to develop, implement, and track emission reduction programs; to improve availability of data and other technical information; and to invest substantial funding in the community through voluntary incentive funding measures. Importantly, these measures are guided by advice and knowledge of local community members, through their input and involvement on Community Steering Committees (CSCs) for each AB 617-selected community.



The District continues to collaborate with each of the CSCs, made up of residents, and representatives from local non-profits, businesses, and agencies, to prioritize and implement the measures included in the District Governing Board-adopted, CARB-approved Community Emission Reduction Programs (CERPs). These efforts include engaging with Valley residents, businesses, agencies, and other stakeholders to identify and implement clean air measures and investments in the selected communities. Since adoption of the CERPs, the District has been working closely with the CSCs and local partners to implement CERP measures designed to reduce air pollution and exposure in the communities. In addition to the CERP implementation work, the District has worked diligently to implement the Community Air Monitoring Plans in consultation with the CSCs, with extensive air monitoring now being deployed and conducted in each of the communities.

# **IMPLEMENTATION PROGRESS IN STOCKTON**

The community of Stockton was prioritized by the Air District and subsequently selected by the California Air Resources Board (CARB) as one of the second-year communities selected in the state to receive clean air resources available under AB 617, based on a technical analysis of several pollution and socioeconomic-related criteria. The Stockton AB 617 community boundary, as designed and approved by the CSC, is approximately 16 square miles and has an estimated population of 132,000. The AB 617 Stockton community is impacted across a number of health and pollution indicators. Using the State CalEnviroScreen (CES) tool, all census tracts located

within the Stockton community rank in the top 5% most disadvantaged communities in California. Stockton also contains the highest ranked census tract in the District's Northern Region (San Joaquin, Stanislaus, and Merced Counties) for overall CES score, which represents a number of health and socioeconomic factors (asthma, cardiovascular disease, low birth weight, educational attainment, housing burdened low-income households, linguistic isolation, poverty, and unemployment).

Based on emissions inventory and current air monitoring data in this community, pollutants of concern include particulate matter less than 2.5 micrometers in diameter (PM2.5), Black Carbon (BC), Oxides of Nitrogen (NOx), Carbon Monoxide (CO), Ozone (O<sub>3</sub>) and Volatile Organic Compounds (VOCs). A virtual tour of the Stockton AB 617 community, produced by the Community Steering Committee to highlight some the community's challenges can be viewed here: <a href="https://www.youtube.com/watch?v=UuQuoSy26x4&feature=youtu.be">https://www.youtube.com/watch?v=UuQuoSy26x4&feature=youtu.be</a> Throughout the past year, the Stockton Community Steering Committee (CSC) worked in collaboration with CARB, the District, agency partners, residents, advocates, industry, and other stakeholders to prioritize and implement the various commitments in the Community Emissions Reduction Program (CERP) and Community Air Monitoring Plan (CAMP) addressing these community air quality concerns.

Air pollution emission reduction and exposure reduction measures implemented under AB 617 programs will further advance ongoing state and District efforts to reduce regional and community exposure to air pollutants. In the preparation of this CERP, the District has worked closely with the CSC, CARB, and the public. The CSC includes residents, community-based organizations, community members, environmental organizations, regulated industry representatives, local agencies, and other key stakeholders and worked to develop strategies and an implementation plan to reduce harmful air pollutants in the community of Stockton AB 617 Community. The plan developed through this collaborative process employs proven and innovative strategies, and significant resources, to improve community health by reducing exposure to air pollutants in Stockton AB 617 Community. This report summarizes the progress of CERP implementation in Stockton from **September 1, 2022** to **August 31. 2023**.

# STOCKTON COMMUNITY ENGAGEMENT

#### Community Engagement

To ensure successful implementation of AB 617, residents, businesses, non-profits, local and state agencies, and other stakeholders within Stockton have been fully engaged in several regular and ad-hoc CSC meetings. The District has ensured that the CSC meetings continue to facilitate inclusive and balanced public engagement by providing:

- Meetings held primarily virtually, via Zoom, with an in-person CSC meeting held in April 2023 at the Stockton Memorial Civic Auditorium.
- Resident Stipend Program to encourage sustained and meaningful community engagement and help cover time and expenses associated with attending meetings and participating in process
- Monthly agenda-setting meetings with District, stakeholders, community co-hosts, CARB, and a third-party facilitator to collectively set expectations and plan for upcoming CSC meetings
- Real-time interpretation services in all languages requested by CSC members and members of the public, which to date is English and American Sign Language
- Subject matter expert presentations from partner agencies such as CARB, Office of Environmental Health Hazard Assessment (OEHHA), Port of Stockton, and Stockton Unified School District
- A comprehensive and dedicated multilingual community specific webpage with tools to view real-time community air quality monitoring data, maps of emissions, CSC meeting materials, historical documents and email correspondence with CSC members, annual implementation and enforcement report, and process guidance documents
- Meeting facilitation to ensure meetings are inclusive and neutral by bringing out different points of view and preventing individuals from monopolizing discussions
- Weekly phone calls and text exchanges with members who request frequent check-ins and meeting reminders.
- Monthly evening meetings via Zoom, with technical assistance provided to residents and stakeholders upon request
- Meeting materials posted ahead of meeting, and send in hardcopy for those who request to facilitate more productive virtual meeting environments

The District also ensures that community members stay updated on public engagement opportunities regarding topics of interest to them and to solicit additional community input through email. All District communications with the CSC are available on the community specific webpage under "Communication with Members". The District also used outreach and media events as opportunities to share information regarding AB617 and to promote the various grant programs available. Additionally, District staff provides updates and seeks feedback from the Citizens Advisory Committee (CAC) and Environmental Justice Advisory Group (EJAG) as the implementation of AB 617 in the Valley continues to develop.

Involving the public in the CERP implementation process continues to be a priority of the CSC and the District. All CSC meetings are promoted on social media and live streamed on Facebook with the meeting videos archived on the Stockton webpage: <u>http://community.valleyair.org/selected-communities/stockton/</u>

#### CSC Feedback for Transparent and Successful CERP Implementation

As the Stockton CSC moved into its second year of CERP implementation, the committee supported several discussions to reflect on shared values, lessons learned and opportunities for growth and prioritize topics for upcoming meetings to guide CERP implementation. Taking this intentional time to reflect on these topics as a whole committee has helped the District and CSC to build consensus around decisions being made and to be able to use CSC member's values to guide decision-making.

#### Values Discussion to Support CERP Implementation

Led by the facilitation team and in collaboration with the community co-host, the CSC participated in an exercise to explore the values that drive a CSC member's decision-making process in the AB 617 process to assist in prioritizing how to provide recommendations for reallocating CERP funds in the future. Some of the most important values shared by the CSC were maximizing emissions reductions, pursuing solutions that protect communities as soon as possible and ensuring that funding is allocated as soon as possible. Recognizing that these values are not exclusive, many CSC members prioritized seeking solutions that bring benefits to the community as soon as possible. Following this discussion, the District solicited CSC recommendations on adjusting funding for the fireplace woodstove change-out program, in which community members supported increasing the funding to support the measure to reduce financial barriers to participate in the program. The feedback shared during this exercise continues to help guide the District and CSC to support CERP implementation

#### End-of-Year Reflection Exercise

In preparation for the final meeting of 2022, CSC members recommended having an opportunity to reflect on the past year to identify successes and challenges of 2022 and to plan for 2023. While in breakout rooms, CSC members and agency staff engaged in these questions to establish practices that should be continued in 2023 and to determine practices that could be adjusted to address challenges CSC members experienced. The below image captures notes from this discussion. Successes included the subcommittee structure and CSC member led meetings and areas for adjustments included focusing on CERP measures that may face challenges in completing and that directly benefit people living in the community.

#### Strategic Planning Exercise

While the agenda-setting meetings have always been a space to reflect on the past CSC meeting and set the agenda for the next meeting, these meetings are optional and not everyone is able to attend due to various conflicts. After observing lower attendance in these meetings, the District worked with the facilitation team and CSC members to pilot a new process for getting the CSC's feedback with a strategic planning exercise to determine the topics for the upcoming quarter during a CSC meeting. The District prepared a handful of recurring topics as well as CERP measures that in the coming months were time-sensitive and required CSC feedback. During the exercise, CSC members then added their own suggestions and had the opportunity to elect topics collectively and transparently for the upcoming quarter, including the April 2023 in-person CSC meeting. The District appreciated hearing from so many CSC members and plans to hold a similar exercise in the coming months.

#### In-Person CSC Meeting

In April 2023, the Stockton CSC hosted its second ever in-person community meeting since the start of the COVID-19 pandemic. With more than 40 community participants, including residents, local businesses, community-based organizations, and partner agencies, the event fostered interactive and engaging exercises on air quality education and community outreach for both CSC and public members centered on soliciting meaningful community input on CSC goals. During the meeting, several of the meeting participants shared their appreciation for the work put into holding an in-person meeting and that the design of the meeting lent itself to productive conversations to move CERP measure implementation forward.

Participants were also invited to tour the District's air monitoring van, which performs mobile air monitoring throughout the San Joaquin Valley. For inclusivity, the District arranged for American Sign Language interpretation, children's activities, and dinner catered by three local food entrepreneurs from Stockton Community Kitchen. Moving forward, the District is working with the CSC to incorporate more of these important in-person opportunities in the implementation efforts the Stockton AB 617 Community.



## CERP MEASURE PRIORITIZATION AND IMPLEMENTATION

#### **CERP** Overview

AB 617 legislation requires that a CERP identifies cost-effective measures to achieve emission reduction targets in the community. During CSC discussions to review potential strategies for implementation in the community, Committee members consistently supported and prioritized measures that would reduce emissions from residential sources, while also providing tangible benefits to residents in the community. To that end, in addition to measures that reduce emissions from stationary, area, and mobile sources that are large contributors to the community emissions inventory, many of the measures supported by the Steering Committee and adopted in the Stockton CERP include targeted incentive programs and interagency partnerships that provide co-benefits in the community, in addition to air quality improvements. The measures in the CERP encompass a range of strategies to reduce community level exposure burden, including regulatory, enforcement, outreach and education, voluntary incentive-based programs, as well as partnerships with other agencies to address issues outside of the District's direct regulatory authority.

#### **CERP** Measure Prioritization

In order to help the CSC and District identify how to progress forward in implementation, the CSC requested that the membership work through an exercise to identify priorities and help organize the measures in categories and subcommittees. The CSC priorities mirror the priorities of the CSC throughout CERP development; emissions reductions from the highest-impact sources are of top priority.

#### **CERP** Implementation Progress

#### AB 617 RESIDENTS GET FREE AIR PURIFIERS

In collaboration with CSC and Indoor Air and Weatherization Subcommittee, the District kicked off the Stockton AB 617 Clean Air Rooms Program to provide CARBcertified high-efficiency residential air filtration units to residents. Eligible first-time applicants residing within the Stockton AB 617 boundary had the opportunity to participate and receive a free portable air filtration unit for their homes. The District coordinated outreach both within the Stockton boundary and across the Valley, educating residents on ways to find air quality information and encouraging them to apply for the District's Clean Air Rooms program to assist in purifying indoor air spaces during periods of poor air quality.

The air purifiers distributed through the program are certified by the California Air Resources Board and HEPA-rated and can reduce indoor particulate matter by over 90% in well-sealed environments. By creating a dedicated "clean air room" such as a bedroom, residents can ensure that they have a space with safe indoor air quality when smoke events occur.

To get the word out about the program, the District worked with the CSC, local community-based organizations, health agencies, and more to do program outreach and assist with applications.



#### **Clean Air Rooms Outreach Materials**

Following the approval of the CERP, the CSC made recommendations on CERP measures for the District to take the lead on to streamline implementation and given the District's experience on the programs, while still bringing back updates to the CSC for input, direction and feedback. The below are highlights on a few of those measures.

Since the project plan was approved in early 2022, the District began working with partnering agencies to install EV charging infrastructure to support the deployment of battery electric and plug-in hybrid vehicles. To date, 21 units have been installed throughout the boundary and the District will continue to conduct outreach for this measure.

#### Car Share Program

During the CERP development process, the CSC identified partnership opportunities to leverage existing efforts to bring a car share program to the community. Following District Governing Board approval, District staff is working with the Housing Authority of San Joaquin County to finalize a contract and expects implementation to begin next year.

#### Passenger Vehicle Repair and Replace Program

In August 2023, CARB approved project plans for both the Passenger Vehicle Repair and Replace programs. Following District Governing Board approval, the District will work with the CSC on these are two prioritized measures to conduct outreach and ensure successful implementation of the programs. make progress on CERP implementation, including completing the Heavy-Duty EV Charging Infrastructure measure.

#### **Subcommittees**

Following the approval of the CERP, the CSC established a series of subcommittees to help divide the CERP implementation work among community and agency partners. The <u>ten subcommittees</u>, each led in collaboration with one or more CSC members, meet regularly to help move forward project plans, track implementation, recommend project partners, and brainstorm outreach tactics. For example, the Trees subcommittee reviewed and provided feedback on the project plan ahead of being submitted to CARB for approval and the Request for Proposal ahead of being released to solicit an entity to implement the programs. The Indoor Air and Weatherization Subcommittee provided feedback on program eligibility and outreach aspects of the residential air filtration project plan. All CSC members and the public are invited to participate in every CSC subcommittee meeting, and regular updates are provided by co-leads either during regular CSC meetings or via email to the CSC when appropriate.

### EMISSIONS REDUCTION TARGETS AND METRICS FOR TRACKING PROGRESS

The District and CSC included a robust set of metrics to track progress in the Stockton CERP. To the maximum extent possible, the District has looked to tie emissions reductions targets to individual CERP measures. Of the 47 measures in the adopted CERP, 17 are incentives measures where the District and CSC worked to identify the number of units targeted for replacement, by year, throughout implementation of the CERP. The remaining measures, whether incentive-based, enforcement, outreach, mitigation, or a land use partnership, have metrics that outline the expected emissions reductions, number of planned inspection hours, scheduled meetings, or other interactions expected for the implementation of the each measure. The District continues to reassess and evaluate these metrics with the CSC as CERP implementation meetings continue. As CARB approves the District's project plans and incentive based measure spending increases, the District will keep the CSC apprised at subscription rates for the various measures and will solicit feedback on whether funding amounts need adjusting.

The CSC has made it clear that having the ability to track and measure implementation progress is very important. The District developed a measure tracker that is updated on a monthly basis on the top of the Stockton AB 617 Community Webpage under the heading "Track Stockton Progress". District staff have taken the opportunity to share the tracker with the community on multiple occasions and have taken and incorporated feedback from CSC members.

### **INCENTIVES MEASURES**

The approved CERP includes numerous incentive-based measures identified and prioritized by the CSC. These measures include a variety of projects and programs that are already approved for funding through CARB's Community Air Protection (CAP) Guidelines, including electric school bus replacement, school filtration, truck and off-road equipment replacement and alternative fuel infrastructure.

The District had been working closely with the CSC on prioritizing and implementing these measures as feasible throughout the community. The CERP also includes numerous measures that fall outside of the pre-approved program categories included in the CAP Guidelines. However, the CAP Guidelines include a process to develop project plans for these new and innovative CERP incentive measures for funding utilizing available funding.

#### **Project Plans**

For all incentive-based measures that require project plans under the CAP guidelines, the District has been working to draft and submit plans to CARB for review and approval. As project plans are pending and approved, the District has worked with the CSC to solicit outreach and implementation feedback for each measures. The figure below describes the status of the various CARB-required project plans as of August 31, 2023.

The CSC is notified, via email and during CSC meetings, as new project plans are developed and submitted to CARB for approval to be able to provide input and feedback on any requested changes, including possible changes to the recommending funding amounts. These project plans are posted on the District's Community webpage to encourage CSC comments and feedback during the process, allowing CSC members to suggest changes to incentive measure funding amounts. The District is currently drafting and will work with the CSC to finalize project plans for three remaining incentive measures including, the Truck Reroute Study, EV Charging for Anti-Idling, and EV Mechanic Training.

#### Community Input on Incentives Program Funding Changes

To ensure successful and community-centered implementation of the incentive-based measures, the District provides updates to the CSC on the implementation budget on a biannual basis. This allows CSC members the opportunity to provide important feedback and recommendations on how to move forward with implementing their CERP measures. In some cases, we have found measures that are no longer feasible as originally aspired to in CERP development. In this reporting period, the District worked with the community co-host to have these budget discussions in January and June 2023 to review short-and long-term CERP implementation and funding liquidation deadlines.

Throughout the CERP implementation process, the District has worked closely with the CSC to assess interest, understand evolving priorities, and support reallocating funding, as described below. The CSC-recommended adjustments were made through a transparent public process, during CSC meetings and were in line with the governance structure laid out in the community charter.

### DISTRICT ESTABLISHED NEW MINI GRANTS PROGRAM FOR COMMUNITY GROUPS

The District launched a program in early 2022 to award up to \$2,000 per organization to assist with onthe-ground grass-roots outreach to help promote to the public in the identified AB 617 communities of South Central Fresno, Shafter and Stockton the various information, resources and/or incentives available to the public as identified in a particular CERP.

The on-the-ground grass-roots outreach may include door-todoor canvassing, hosting outreach events, or conducting presentations in one or multiple languages. However, the District is open to new ideas and encourages innovation.

In Stockton, three mini grants have been awarded for various community-led outreach campaigns. In addition to working with the CSC on funding reallocations, the District also continues to work with the CSC to reassess and expand project plans when incentive measures are facing challenges. For example, there are challenges statewide for businesses to take advantage of the heavy-duty truck replacement program to transition to electric trucks, as the technology is new and businesses are not familiar with if it will be feasible for their operations. Building on work done in the Heavy-Duty Truck Subcommittee, the District brought a concept to the CSC for discussion, based on a project plan approved in another AB 617 community, to allow for businesses to expand their fleets by purchasing zero-emission trucks without the need to scrap existing compliant vehicles. The CSC provided valuable input and asked critical questions to support the development of the project plan, and ultimately supported submitting a new project plan to CARB with this additional pathway for participation.

The District will continue to work closely with the CSC throughout this process to prioritize funding in areas and programs of specific interest to the community and incorporate new program ideas based on CSC member feedback and recommendations as feasible.

## OUTREACH AND MITIGATION MEASURES

During CERP development, the Stockton CSC recommended that the District engage in a wide variety of multilingual outreach efforts via both traditional and social media to allow community members to see and learn about air quality issues, take advantage of grant programs, and provide real-time access to information from air monitoring equipment deployed as part of the AB 617 process. Members of the Steering Committee acknowledged the District's ongoing air quality outreach and education efforts, but expressed concern about effectiveness given perceived public indifference. Effectiveness could be improved by increasing the volume and types of outreach, focusing it to a truly localized level, and using partnerships with key local organizations to better understand how to deliver needed information to the Stockton community residents.

The CSC and District established annual goals within the CERP targeting a number of community meetings and media campaigns to increase awareness and help the public become more informed on air quality issues. To help direct those goals, and drive the outreach and education process, the CSC formed an outreach subcommittee, chaired by several community groups. This subcommittee meets bi-monthly to check progress, coordinate outreach events, provide feedback on outreach materials, and touch base with other Stockton CSC subcommittees on outreach needs for CERP-specific measures. Though these efforts, the team has established an <u>outreach resources page</u> on the Stockton CSC website, which contains multilingual outreach materials and an application for community groups to receive funding to conduct on-the-ground outreach campaigns in the community.

#### Outreach Events in the Community

Through AB 617 implementation in Stockton, the District has worked to better understand the community and develop local strategies to increase community awareness of clean air efforts, funding opportunities and how residents can get involved. Directly engaging residents at events continues to be a priority for the District and CSC. The District and CSC members had a presence at multiple summer and fall events—from neighborhood picnics to resident fairs—to talk to residents about Clean Air Rooms, changing out their old dirty fireplaces, considering electric vehicle technology and just generally sharing the many clean air resources available to the Stockton community.





#### Stockton Show-and-Tell Event

In February 2023, following the approval of Stockton's fireplace change-out project plan, the CSC and District coordinated an in-person event to help educate local residents on the benefits of cleaner home heating. During the event, attendees from the Stockton area visited tables where hearth retailers were waiting to answer fireplace questions, show examples of gas inserts and discuss the various cleaner options to change-out wood- or pellet-burning devices to heat a home. District staff were also on hand to help residents who were ready to start their Fireplace & Woodstove Change-Out application and answer questions about the program. Approved Stockton applicants received a voucher worth up to \$5,000 toward the purchase of a new gas or electric residential heating device.

#### Stockton Back-to-School Outreach

In August, District staff visited elementary schools within the boundary to pass out information to parents about avoiding idling, protecting themselves from wildfire smoke impacts with the District's Clean Air Room's program, how to take advantage of clean air funding through AB 617. This "back-to-school" outreach campaign occurred over several weeks and allowed District staff to connect with school personnel about air quality, help parents sign up for free residential air purifiers and get students excited about the science of air quality.



## COMPLIANCE AND ENFORCEMENT MEASURES

During the development of the Stockton CERP, CSC members identified several primary sources of concern within the community. Based on the analysis of the District's enforcement history within the AB 617 community, several focused enforcement and compliance assistance measures were included in the CERP aimed at enhancing enforcement and education efforts through existing District enforcement programs to address those areas of community concern discussed below. In addition to the implementation of the enforcement measures adopted in the CERP, the District's Compliance Department has continued over the past year to promptly respond to public air pollution complaints in the community.

#### Enhanced Enforcement of Regulation VIII Fugitive Dust Requirements

District rules limit fugitive dust emissions from construction, demolition, and earthmoving; bulk material storage; open areas; and unpaved roads and vehicle/equipment traffic areas. Furthermore, District rules restrict carryout and trackout onto paved public roadways. In order to facilitate enforcement of fugitive dust prohibitions, a Construction Notification or Dust Control Plan is required for all construction activities in the District involving one or more acre of disturbed surface area.

To address the community concern of construction/earthmoving dust emissions, the District conducted inspections of construction sites within the community with active Dust Control Plans or Construction Notifications pursuant to District Rule 8021 to enforce the fugitive dust emission standards contained within District Regulation VIII. Additionally, the District also conducted general area surveillance for other potential sources of fugitive dust in the community.

#### Enhanced Enforcement of Statewide Anti-Idling Regulation

To address the community concern of heavy-duty trucks and to limit the potential for localized PM2.5 and toxic air quality impacts associated with the failure to comply with the state's heavy duty anti-idling regulation, the District staff performed quarterly anti-idling surveillance. Locations where surveillance was conducted were based on CSC input provided to the District and CARB. To ensure District staff continue focusing in the areas where residents are being impacted , the District has included discussions in CSC meetings to provide updates on these efforts and to receive CSC feedback on areas to be focused on while doing surveillance, and will continue to do so moving forward. District staff also spoke directly to businesses who rely on heavy-duty trucking, identified by the CSC, to provide compliance assistance and education regarding the state's anti-idling Airborne Toxic Control Measure requirements and steps to be taken to ensure compliance. Although only three violations were discovered during the surveillance performed, the District believes that the outreach provided to businesses in community will contribute to increased compliance with the state's requirements.

#### Enhanced Inspection Frequency of Stationary Sources

The District conducts inspections and investigations of both permitted sources to determine compliance with a multitude of health-protective local, state, and federal air quality regulations targeting both criteria and toxic pollutants. These include (1) District rules and permit requirements; (2) statewide Airborne Toxic Control Measures; (3) statewide greenhouse gas regulations; and (4) federal New Source Performance Standards, National Emission Standards for Hazardous Air Pollutants, and Maximum Available Control Technology standards. The District closely monitors such sources and strictly enforces applicable requirements. Compliance evaluations are unannounced whenever possible and involve both a physical inspection of the facility and a review of operating and monitoring records.

To address the community concern of industrial processes and other permitted sources of air pollution, the District reviewed the enforcement history of all permitted facilities in the community, and for each facility having an emissions violation within the last three years, the District committed to performing inspections of these facilities at least twice per calendar year for the next five years or until the facility has four consecutive inspections without an emission violation, whichever comes first. District staff has fully implemented this measure and increased inspections of these facilities is ongoing.

#### Regulatory and Enforcement Subcommittee

As the District provides regular updates to the CSC on enforcement actions and upcoming regulatory processes, the CSC was interested in establishing a subcommittee to provide a dedicated space for discussion and in-depth

analysis of statewide and local enforcement of air quality rules. During the subcommittee's first meeting, the group, led by a Stockton resident, worked together to establish a common purpose.

In order to provide transparency and empower community members, it is important that the District, CARB, and the CSC work together to better communicate to the residents and business communities what the air pollution control regulations are, how the agencies work together to take action, and how community members can use their local knowledge to file complaints. The Regulatory and Enforcement Subcommittee is eager to stay informed and work with the agencies to make a difference in the community. *-Regulatory & Enforcement Subcommittee notes* 

The subcommittee established a schedule of sources and discussion topics, starting with the highest polluting source categories of on and off-road mobile sources. During this reporting period, the subcommittee engaged in the following topics: truck enforcement from the community lens, enforcement of fugitive dust requirements, enforcement of biomass sources and the District's Indirect Source Review program. The District will continue to work with the subcommittee co-lead and any interested CSC members to discuss regulatory and enforcement topics of interest to the CSC.

# DISTRICT REGULATORY MEASURES

During CERP development, and throughout implementation, the Shafter CSC has worked with the District on developing measures that reduce PM2.5 and toxic air contaminant emissions that originate from industrial sources in and around the community. Beyond the regulations and stringent permitting requirements that are already implemented Valleywide, the District worked with the CSC to implement regulatory strategies in the following categories. As discussed in the Enforcement section of this report, the regulatory commitments in the CERP are to be discussed in depth with the CSC during the Regulatory and Enforcement Subcommittee meetings.

#### PM2.5 Plan Rule Updates

District staff have continued moving forward with technical evaluation and public engagement efforts for scheduled regulatory measures, with several District rules scheduled for proposed amendments in the 2021-22 timeframe. Emissions reductions achieved through the implementation of more stringent limits potentially required through these rule amendments will further contribute to reduced exposure to air pollution in the community. CSC members, members of the AB 617-selected community, and the general public are encouraged to be involved in the upcoming rulemaking process for these rules.

#### Best Available Retrofit Control Technology (BARCT)

AB 617 required districts that are in nonattainment for one or more air pollutants to adopt expedited schedules by January 2019 for the implementation of Best Available Retrofit Control Technology (BARCT). Significant work was necessary to demonstrate that existing rules met BARCT requirements or, where it was not clear that BARCT requirements were met, identify potential gaps in the existing rules, establish a rule-review schedule, and take the schedule to the District's Governing Board for approval before the deadline. The Board adopted the District's BARCT Analysis Schedule on December 20, 2018. The District is now implementing the plan, and, where necessary, develop rule amendments consistent with state BARCT requirements. The District must also share its findings with the state as CARB compiles the BARCT clearinghouse.

Since 2019, the District has performed a further BARCT analysis of 15 of the 16 rules identified, typically in the order of documented priority. Each District rule and source category are evaluated in comparison to federal and state air quality regulations, and the regulations of other air districts in California and throughout the country.

The District held a public workshop on April 20, 2021 and provided a update to the public on the progress the District has made on the BARCT evaluations for 4 rules conducted in 2020 (see published report – link) and discussed the next steps associated with further evaluating the remaining District Rules for satisfying BARCT requirements. The following table summarizes the status of the BARCT rule evaluations.

The District is also working with the affected facilities to identify the potential control options that may result in additional emissions reductions. The affected facilities are providing the District with technical information and costs related to potential control options to determine the feasibility of implementing each option identified.

#### Technology Clearinghouse

AB 617 requires CARB to establish and maintain a statewide clearinghouse that identifies the best available control technology, best available retrofit control technology for criteria air pollutants, and related technologies for the control of TACs.

Since 2019, District staff have been participating in bi-weekly conference calls with CARB and other air district staff to discuss the proposed changes to the statewide clearinghouse and the new database and website

interface that CARB and their programming consultant is creating. Through collaborative discussions, the District has provided input on facility and pollutant definitions; source category, subcategory, and classification differences; public usability and device specificity; and many other topics. To date, CARB has published an initial Technology Clearinghouse webpage<sup>1</sup> and has published, the following prototype tools to support public needs while the remainder of the Technology Clearinghouse system is developed:

- Next Generation Technology (Released November 2019) <u>Emergency Back-up Power Options for</u> <u>Residential Applications</u>
- Rules (Released March 2020) Current Air District Rules Tool
- Next Generation Technology (Released June 2020) <u>Emergency Back-up Power Options for Commercial</u> <u>Applications</u>

Additional meetings have been scheduled and significant work and testing of the new database, tools, and website is still being performed.

#### AB 2588 Air Toxic Hot Spots

The District's integrated air toxics program fulfills the state AB 2588, California Air Toxics Hot Spots, mandates, which are aimed at quantifying and assessing localized health risk, notifying affected residents, and reducing risk from facilities with high risk caused by air toxic emissions. The state Hot Spots Act is only one part of the District's comprehensive program to regulate air toxics in Valley communities. To achieve maximum efficiency and effectiveness, the District operates an integrated air toxics program that implements local, state, and federal mandates.

Since 2021, the District has been implementing a plan designed to expedite the assessment of the health risk associated with each of the facilities located in Stockton. To date, the District has assessed the health risk for 152 facilities within the Community and none of the facilities that have been assessed pose a significant health risk.

#### Implementation of New Criteria and Toxics Report (CTR) Regulation

Under AB 617, CARB is tasked with developing a uniform statewide system for reporting inventories for criteria and air toxic emissions for stationary sources to the public. The uniform statewide system is currently under development. The state's *Regulation for the Reporting of Criteria Air Pollutants and Toxic Air Contaminants* went into effect on January 1, 2020. This regulation requires certain facilities to report their criteria and toxic emissions to the District annually starting with the 2019 emissions year.


# COMMUNITY AIR MONITORING

The community air monitoring plan consists of several platforms including, mobile, semi-mobile, and fixed monitoring, each serving a specific purpose. Mobile monitoring consists of air monitoring vans, which are valuable resources for evaluating the large geographic region comprising the Stockton community. These platforms are best designed for taking an instantaneous look at the measured pollutants when the monitoring occurred. The fixed and semi-mobile platforms are used to measure daily variations in pollutant concentrations. The use of both mobile and semi-mobile monitoring platforms is necessary to capture the full picture of the community's air quality.


#### Community Air Monitoring Development to Date

Throughout the past year, the District engaged the Stockton CSC finalizing deployment of the CSC-designed Community Air Monitoring Plan. After the initial design, which aimed at monitoring impacts directing at schools within the boundary, was determined to be infeasible due to lack of interest from the host sites, the District worked closely with the CSC through the end of 2021 to identify locations for the District to deploy various air monitors.

The map below summarized the current network design. The District is working with the City of Stockton Public Works Department and Taft Community Center to finalize installation of PM 2.5 monitors in zones E and F. All other sites and operational and reporting real-time data. CSC members are regularly updated on status of deployment, including real-time measurements from monitors already installed, on the Stockton-specific community air monitoring website: <u>https://community.valleyair.org/selected-communities/stockton/community-air-monitoring/</u>




Additionally, the District works with the CSC to provide regular updates about air quality measurements and analysis during CSC meetings and quarterly through <u>detailed air monitoring analysis reports</u>. During this reporting period, District staff presented the CSC quarterly air monitoring updates during the November 2022, February 2023 and May 2023 CSC meetings.



## HEALTH IMPACTS OF LOCAL AIR POLLUTION

As discussed in CARB's Blueprint, a core focus on achieving emissions reductions and tracking ongoing progress is needed to address public health risks that may be caused by air pollution exposure. Consideration of public health includes taking health risks into account in identifying and selecting emissions reduction strategies, evaluating health risks in the context of newly acquired air monitoring information, as well as exploring ways to better understand data on community health and its potential relationship to past or ongoing pollutant exposure. In the Blueprint CARB recognizes that individual and community health is influenced by many factors including exposure to other environmental hazards (e.g., drinking water contaminants, tobacco smoke), individual level vulnerability (e.g., diet, genetic factors), as well as structural determinants of health such as neighborhood poverty, racial/ethnic segregation, violence, access to food and health care, and lack of green space.



Towards this end, the District has gathered some baseline data in the Stockton AB 617 Community and will continue to work with the Steering Committee, OEHHA, CARB, and health researchers to track and support local research efforts to understand the public health impacts of local and regional emissions reduction efforts.

#### Tracking Recent Research Efforts

Several recent community-facing public health impact studies have focused their efforts on AB 617, with a focus on tracking public health outcomes of emissions and exposure reduction measures like those in the Stockton CERP. As the community members engage and collaborate with researchers on these studies, the District is committed to tracking, updating, and including the CSC and broader community on study methodologies and outcomes. The Stockton CSC has heard updates on several study efforts in the past year. The below list of recent research efforts in the Stockton community that will continue to help drive the conversation between the CSC and agencies about the effectiveness of these CERP and CAMP efforts.

## Enforcement Plan Summary of Complaints

District inspectors respond to approximately 3,000 public air pollution complaints District-wide each year. Some complaints are related to permitted facilities, however a majority of complaints received by the District are for other sources of pollution such as illegal open burning, fireplace burning, dust generating activities, and miscellaneous odors. The District responds to all public complaints received, and makes every effort to respond as quickly as possible. Most complaints are investigated the same day they are reported. The following is a summary of all public air pollution complaints received and responded to within the Stockton Community from July 2022 through June 2023. A previous report of complaints can be found in <u>Appendix F</u> of the Stockton CERP and in the 2022 annual report.

## Enforcement Plan Summary of Violations Found

The District implements a robust enforcement program that includes regular inspections of facilities with District permits as well as other potential sources of air contaminants. In the Stockton CERP, the District committed to further enhancing its enforcement efforts in a few areas of concern to the community. District compliance staff have completed idling diesel truck surveillance, fugitive dust Regulation VIII inspections, and conducted more frequent inspections at facilities with recent emissions violations.

When a violation of a District rule or other air pollution regulation is discovered during an inspection, complaint investigation, or through surveillance activities, the violation is documented through the issuance of a formal notice to the owner or operator, and depending on the nature of the violation, may be subject to substantial monetary penalties. The following is a summary of all violation notices issued from July 2022 to June 2023 for violations of District Rules or other State air pollution control regulations within the Stockton Community. These include violations at permitted facilities as well as other non-permitted facilities and private residences. A previous list of violations can be found in <u>Appendix F</u> of the Stockton CERP and in the 2022 annual report.

## Enforcement Plan Facility Inspections

Facilities that have permits with the Valley Air District are inspected on a regular basis by District Compliance staff to ensure all permit requirements are being followed. New and modified equipment is also inspected before commencing operation. District inspection staff also observes stack emission testing (known as source testing) types of equipment to ensure that proper testing procedures and protocols are followed by the third-party testing company. They also conduct inspections when unforeseen equipment breakdowns occur which may affect a facility's ability to comply with all permit requirements.

In addition to the numerous inspections already conducted by the District each year at permitted facilities throughout the valley, the District committed in the Stockton CERP to increase the frequency of periodic compliance inspections to once every six months at facilities that have had an emissions related violation within the last three years. The following is a listing of all District inspection activities at permitted facilities within the Stockton Community from July 2022 through June 2023. A previous list of inspections can be found in <u>Appendix F</u> of the Stockton CERP and in the 2022 annual report.
