### Celebrating Recent CERP Measure Milestones

Received application for heavy-duty electric vehicle charging infrastructure

Finalizing contract for Carshare Program with SJ Housing Authority, anticipate Fall implementation for 2 sites

Passenger Vehicle Repair and Replace Project Plans awaiting CARB approval, anticipate August approval

Residential Air Filtration program opened

## Heavy-Duty Truck Replacement Measure

Replace heavy-duty trucks with zero emission trucks at businesses located within AB 617

Stockton boundary

Funding in CERP \$10 Million

**Status**0 trucks replaced

#### <u>Discussion in Heavy-Duty Trucks Subcommittee:</u>

- Challenges for local businesses/single owner-operators to take advantage of program
- Outreach opportunities to local businesses to participate in program
- In May 2023 subcommittee, discussed San Diego APCD Zero-Emission Truck Pilot Program → next steps: bring draft outline of potential project plan changes for CSC consideration



## Proposed Aspects of Project Plan for Submittal

Allow owner-operators within the Valley's Stockton AB 617 boundary to expand their fleets by purchasing new zero-emission trucks without the need to scrap existing, compliant vehicles

Increased funding amount allowed per vehicle replacement

### Details for CSC Consideration for New Pathway

### **Pros**

- Additional pathway for increased program participation in limited implementation timeframe
- Allows small businesses/single owner-operators to become familiar with new, zeroemission technology and see feasibility for their operations


### Cons

 New pathway does not include requirement to scrap an old truck (but traditional pathway is still available)



### Opportunity for New Pathway for HD Truck Measure

In addition to existing/traditional HD truck measure, we are proposing to submit a **project plan** to CARB to add a **new pathway** to allow for local businesses/single-owner operators to expand their fleet with zero emission trucks (no funding reallocation)
