00:48:00 AD-Jessica Olsen (she/her): The equipment selected includes the Blueair Blue Pure 311 Auto portable residential air purifier (including three additional disposable filters to provide at least two years of continuous operation at no cost to program participants), and the IQAir AirVisual Pro indoor air monitoring device. All new equipment is anticipated to be delivered directly to participants via U.S. mail to minimize the spread of COVID-19 and accelerate the timeframe in which participants receive their new equipment. PAIR Program participants may also receive a one-time monetary stipend for the partial reimbursement of expected electricity costs associated with the new equipment operation.

00:48:08 AD-Jessica Olsen (she/her): The APCD also completed a competitive bid process for a contractor to administer the PAIR Program on behalf of APCD and has selected a local organization familiar with the Portside community for this contract. Duties assigned to this organization will include but are not limited to outreach and customer service, selection of participants, translation, case management, and technical support. Air quality data collection and monitoring will be conducted remotely by APCD for each device connected to the internet, through a one-year APCD subscription to the IQAir AirVisual Enterprise Dashboard. Analysis of the data collected, including a comparison of data collected by APCD regional air quality monitors, will be conducted either by the APCD, California Air Resources Board, or another outside entity following the one-year subscription period.
