

## 2022 Outreach Grant Program in Valley Air District's AB 617 Communities

Funds for air quality education and outreach projects related to the Community Emissions Reduction Programs developed by AB 617 Community Steering Committees in South Central Fresno, Shafter and Stockton

### WHAT IS AB 617?

#### What is AB 617 and why is the Valley Air District offering this grant program?

Assembly Bill 617 (AB 617) requires the California Air Resources Board (CARB) and air districts to develop and implement additional emissions reporting, monitoring, reduction plans and measures in an effort to reduce air pollution exposure in state's most disadvantaged communities. Given that 20 of the 30 most disadvantaged communities in California are in the San Joaquin Valley, this process is bringing additional clean air resources and strategies to many Valley communities.

In 2018, South Central Fresno and the City of Shafter were the first Valley communities selected by CARB for investment of additional resources under AB 617. Each year since, CARB has added one additional Valley community. In 2019 Stockton was selected and most recently in February of 2021, Arvin/Lamont was selected. The San Joaquin Valley Air Pollution Control District (District) has been actively engaging with these communities to develop Community Emissions Reduction Programs (CERP) and Community Air Monitoring Plans (CAMP). The 2022 Outreach Grant Program in Valley Air District's AB 17 Communities (Grant) is being implemented to enlist the support of community non-profits in connecting their constituents to information, resources and incentives made available through the CERPs that have been developed in each of the Valley's four AB 617 communities.

### WHAT IS THE GRANT?

#### What is the grant, how much will it fund, and who can apply for a grant?

The District will award up to \$2,000 per organization to assist with on-the-ground grass-roots outreach to help promote to the public in the identified AB 617 communities of South Central Fresno, Shafter and Stockton the various information, resources and/or incentives available to the public as identified in a particular CERP. Potential information and/or resources might include:

The on-the-ground grass-roots outreach may include door-to-door canvassing, hosting outreach events, or conducting presentations in one or multiple languages. However, the District is open to new ideas and encourages innovation, if you have an idea that does not fit within any of these categories; we still encourage you to apply.

### ELIGIBILITY

The District will accept grant applications from schools and universities, student groups, community groups, service clubs, youth organizations, churches, and other not-for-profit organizations located within the boundaries of the Valley Air District.

#### Outreach Project Location

Outreach projects must be targeted at the residents living within the boundaries of one of the District's AB 617 Communities of South Central Fresno, Shafter, or Stockton. ELIGIBILITY

**Eligible Expenses and Payment**

Eligible uses of grant funds include, but are not limited to:

- wages or salaries for direct outreach (such as door-to-door canvassing);
- purchase of materials and supplies;
- equipment rental;
- printing and postage of publicity and promotional materials;
- refreshments and other incentives for volunteers;
- administrative overhead

Awardees will receive 33% of their funding prior to the outreach commencement. Awardees will receive the balance of their grant award upon outreach completion, documentation of expenses, and final paperwork submittal.

ADDITIONAL REQ

In addition to meeting the eligibility requirements and conducting outreach related to a CERP, grant recipients must:

- Obtain all appropriate permissions and permits for the project, if any;
- Provide the District with copies of any documents or materials produced for the project;
- For school projects, provide the District with examples of student work prepared through the project;
- Acknowledge District and CARB in all project promotional materials, printed programs or reports;
- Photograph project activities and provide the District with copies of the photographs;
- Enter into an agreement that holds harmless and indemnifies the District against any damages resulting from the project. The District may also require insurance coverage as appropriate.
- Upon project completion provide the District with a brief final project report.

EVALUATION

The District reserves the sole discretion to determine if an applicant or project meets eligibility requirements, whether proposed expenses are an appropriate use of grant funds, and whether an application is complete. To this end, the District may request supplemental information regarding the project. Staff's evaluation, selection, and recommendations for funding will be based on:

- The proposed project meets the grant objective to conduct public outreach within the District's AB 617 communities about the various information, resources and/or incentives available to the public as identified in a particular CERP.
- The project description, tasks and schedules are clear and complete.
- The budget is adequately detailed and appropriate.
- The project is fully funded. Non-grant funds necessary to complete the project should be available, or be realistically projected to become available within the grant period.
- The applicant demonstrates the ability to coordinate, manage and complete the project.
- The project will result in or contribute to ongoing or long-term efforts, activities and benefits within the community it will serve.

All project funding recommendations will be presented to the District Air Pollution Control Officer/Executive Director for approval or amendment.

ACKNOWLEDGE

This outreach is part of California Climate Investments, a statewide initiative that puts billions of Cap-and-Trade dollars to work reducing greenhouse gas emissions, strengthening the economy and improving public health and the environment — particularly in disadvantaged communities. The program is also supported by the San Joaquin Valley Air Pollution Control District to promote the AB 617 program in targeted Valley communities.
