2. Three CARB Data Tools Available to View Best Available Control Technologies and AB 617 Community Focused Air Quality Data

CARB OCAP has made available three data tools to view best available control technologies, AB 617 incentives projects, and summary of AB 617 activities.

- The <u>Technology Clearinghouse</u> identifies the best available control technology (BACT) and the best available retrofit control technology (BARCT) for criteria air pollutants, and related technologies for the control of toxic air contaminants. Included in this clearinghouse:
 - o The <u>Air District Rules</u> tool allows users to search, view and download information related to current air district rules.
- The AB 617 <u>Community Hub</u> is an online dashboard that provides visual summaries of key AB 617 efforts on community air monitoring and community emissions reduction programs, incentive investments, and enforcement activities in communities.
- <u>Community Air Protection Incentives Project Dashboard</u>, a tool to track incentives projects across the state and in specific AB 617 communities. Included in this dashboard:
 - A new <u>Stationary Source Permitting Community Questions</u> webpage answers questions related to stationary source permitting raised by community advocates.
 - The <u>Enforcement Data Visualization System</u> is a map-based tool for users to visualize CARB's enforcement activities throughout the State, including field inspections and case settlements.

3. Community Air Grants Funding Process Begins and \$10 million Expected Available for Funding

CARB's <u>Community Air Grants Program</u> will soon be requesting applications to help support community-based organizations and tribal governments to participate in the AB 617 process and implementation. Ten million dollars will be available for funding, which can be used to help communities build capacity to become active partners with government to identify, evaluate, and reduce air pollution and exposure to harmful emissions in their communities.

Request for applications will begin December 5, 2022, with the application deadline of March 3, 2023.

For the first time, Community Air Grants can now be used to allow communities to write their own local Community Emissions Reduction Plans, along with other types of projects such as:

- Community engagement and outreach related to AB 617
- Hiring consultants and/or technical experts

- Travel and logistical support for hosting and/or attending meetings related to AB 617 (i.e., room rental, meeting facilitation, transportation)
- Support for community operated air monitoring
- Data collection and analysis, including community based participatory research projects
